VFW MEMBERSHIP ELIGIBILITY

There are three qualifiers for membership in the VFW, as set out in our By-Laws.

An individual must meet all three in order to become a member. They are as follows:

- 1. Citizenship must be a U.S. citizen or U.S. National.
- Honorable Service must have served in the Armed Forces of the United States and either received a discharge of Honorable or General (Under Honorable Conditions) or be currently serving.
- 3. Service in a war, campaign, or expedition on foreign soil or in hostile waters*.

This can be proven by any of the following:

- An authorized campaign medal (see full list of medals and badges at VFW National Website)
- Receipt of Hostile Fire Pay or Imminent Danger Pay (verified by a military pay statement)
- Service in Korea for 30 consecutive or 60 non-consecutive days
